Subject: Request for Clear Guidance regarding Internship Duration for FMG Students.

Sir/Madam,

In reference to the above cited subject matter, I am directed to inform you that this council has allotted CRMI/internship to FMG candidates/students for 1 year or 2 years or 3 years as per the Public Notice dated 07/12/2023 and FAQs dated 11/12/2023, however this council has received numerous requests from FMG students pertaining to reduction of their CRMI/internship duration from 3 years or 2 years to 1 year, thereby making them eligible for permanent registration. Further, FMG students have presented information suggesting that several state medical councils across India have adopted a policy of allocating a 1-year CRMI/internship period to those FMG students who have pursued their study through online classes at their parent college/institute in a foreign country, subsequently making them eligible for permanent registration.
